## Review Draft 2024 Pension Fund Budget -

Administrator Hartley reviewed the proposed 2024 Pension Fund Budget with the Board.

#### Administrator's Report:

Thank you, Tim, for accepting Board membership for another two years! Tim was the only selfnomination form received and will continue to over the next two years.

FPPA year-to-date financial reports for the 2nd quarter of 2023 are attached. FPPA is reporting positive interest for this quarter, 1-year, 3-year, and 5-year at 2.73%, 8.92%, 9.47% and 7.81%.

Remember that the plan assets are commingled for investment purposes. The ending balance of the Volunteer Fund for the 2nd quarter is \$3,804,826.85 compared to the beginning balance of \$3,795,300.22. The small increase in the balance of \$9,526.63 is due to the investment unrealized gain, interest, and dividends less expenses.

The Volunteer Fire Department Actuarial Valuation Results are included in this month's Board packet. This is the source document for information regarding actuarially determined contributions and the funded status of the pension plan. This is the plan document used to make the decision on further funding from the District to ensure that pension benefits are funded in a sustainable manner. The District is ultimately responsible for funding the plan appropriately.

Please view page 8 of the document titled Executive Summary. This is the page that includes a condensed summary of the demographic, financial, and actuarial data 2023 vs 2021 that will be discussed in the Board meeting.

The proposed Summit Fire & EMS Fire Protection District contribution to the Volunteer Fund for 2024 needs to be decided based on the 2023 Actuarial Study received in this Board packet.

#### **Board Member Comments:**

Director Sinclair commented that the District should consider extending funding over the amount done in the past to get ahead of the actuarial schedule.
