## Review Draft 2024 Pension Fund Budget -

Administrator Hartley reviewed the proposed 2024 Pension Fund Budget with the Pension Board.

#### Administrator's Report:

FPPA year-to-date financial reports for the 3<sup>rd</sup> quarter of 2023 are attached. FPPA is reporting positive interest for the 1-year, 3-year, and 5-year at 10.13%, 6.78%, and 6.83%. The third quarter is showing negative interest of (2.23)%.

Remember that the plan assets are commingled for investment purposes. The ending balance of the Pension Fund for the 3<sup>rd</sup> quarter is \$3,614,723.43, and as compared to the beginning balance of \$3,795,300.22, shows a decrease of \$180,576.79. The Summit Fire & EMS Fire Protection District ("District") contribution of \$91,082 will show up in the fourth quarter along with investment expenses.

The District contributed \$91,082.00 to the Pension Fund for 2023 in October 2023. This makes the fund eligible for state matching funds of \$81,974.00 in 2024.
